# Baton Rouge, LA – Mental Health Tax

**Presenter:** Jared Hymowitz, Director of the Mayor's Healthy City Initiative, City of Baton Rouge

**Description:** The council authorized a 1.5 mills tax for a period of 10 years to be used entirely and exclusively for the purpose of operating and maintaining a treatment center that will provide mental health and substance abuse services.

### **Denver, CO – Caring for Denver**

**Presenter:** Lorez Meinhold, Executive Director, Caring for Denver

Description: Founded and funded by Denver, Caring for Denver Foundation was created on November 6, 2018 when seventy percent of Denver turned an idea into a reality. The ballot initiative was simple, yet powerful. For every \$100 spent in Denver, 25 cents totaling over \$30 million dollars (dependent on the economy) goes toward addressing mental health and substance misuse needs in Denver. The increased revenue will be used for mental health services, including suicide prevention programs; substance abuse treatment, prevention, and recovery programs; facilities and programs for those with mental health diagnoses; and training for first responders. The goal of the program is to improve long-term recovery rates, reduce the use of substances, decrease homelessness, and take the burden of dealing with mental illness away from the courts and place it in the hands of treatment providers.



# King County, WA – Mental Illness and Drug Dependency (MIDD) Sales Tax Levy

**Description:** King County's MIDD is a countywide 0.1% sales tax generating an about \$136 million per two-year biennium, specifically for programs and services for people living with or at risk of behavioral health conditions.

#### California – Mental Health Services Act

**Description:** Proposition 63, now known as the Mental Health Services Act, imposed a 1 percent tax on people who earn more than \$1 million annually to pay for expanded mental health care in California. Since its passage, it has generated approximately \$15 billion for counties in California to provide mental and behavioral health services.
