**Description:** COVID-19 Community Conversations (3C) is an initiative focusing on Mental Health, Equity & Resilience. This initiative provides widespread education and support in neighborhoods disparately affected by COVID-19. The 3C program holds structured discussions with communities about the mental health impact of the pandemic, including structural racism, providing coping and resiliency skills, and informing residents of available mental health resources. Discussions are currently offered in English, Spanish and Chinese.

The NYC Health Justice Network (HJN) works with persons returning to the community from jail or prison to make reentry as positive as possible. The HJN addresses systemic racism and discrimination embedded in many US foundational systems by employing Community Health Workers (CHWs) with lived experience of the criminal legal system to work with participants in a welcoming, empowering and non-stigmatizing way. Participants are paired with a community health worker (CHW) who specializes in health and reentry and works to Bridge Public Health and Health Care and Create Healthier Neighborhoods. CHWs provide holistic and voluntary services, working with participants to facilitate access to health, dental and specialty health care; employment and education services; mental health and substance use supports; referral to housing resources; legal support; coaching; peer support; family support; and more.
